MECCN was awarded a small grant under Strategic Direction 4; Increase local, national and regional capacity to conserve biodiversity through catalyzing civil society partnerships in

particular contributing to Investment Priority 4.1 Strengthen the capacity of local and national civil society organizations in financial management, project management and organizational governance.

MECCN developed a constitution, a strategic plan, and an organization structure for the organization which are yet to be reviewed. A financial system was being negotiated with other civil societies to have one established for MECCN.

CBOs including TARM and Pere Alalau CBO are members of MECCN having membership in its Board of Management.

All LLGs were invited and attended a workshop to review the documents at the end of 2017. These have yet to become are yet to become financial members of the organization. Communities in the hotspot for endemic species on Manus have become extremely keen on participating in the conservation their area for the protection of endangered species of fauna. Other CBO around Manus have shown high level of interest to participate in conservation and protection of biodiversity in Manus as indirect impact of the Project.

3. Please summarize the overall results/impact of your project against the expected results detailed in your approved proposal.

Drafts of the governance structure, strategic plan and constitution were developed by the office for a one week meeting.

A planning workshop was conducted in November 2016 to review and revise the MECCN organizational governance structure, strategic plan and constitution. Participants to the workshop included representatives from the 12 LLGs, LMMAs, CBOs, TNC and the Provincial Government. The official opening of the MECCN office was also launched during the planning workshop.

4. Please describe any successes and/or challenges faced towards achieving the expected short-term and long-term impacts of the project work.

Successes

- Set up of MECCN office and equipment achieved. The strategic planning workshop was conducted in November 2016 to review MECCN organizational governance structure, strategic plan and constitution which involved a good representation of local CBOS, LLG reps, government and other international NGOs.
- Drafts of the governance structure, strategic plan and constitution available for endorsement.

Challenges

- Managing the project to achieve the expected results.
- Partner/Stakeholder engagement to assist in achieving MECCN's activities related to financial management.
- Informed Involvement of partners/stakeholders for shared values.
- 5. Were there any unexpected impacts of your project (positive or negative)? As a result of this grant, other CBOs, NGOs and the Provincial Government and Administration were able to learn about MECCN and

Communities and other private and public agencies not necessarily having direct link with of conservation of biodiversity and protection of the environment have increased interest with the issues involved.

Members of other groups, for example: women in environment have differing views on the approaches to the issues. Similarly, members of other groups became members of MECCN thus bringing with them learnings and biases.

 WCS to assist with this activity did not eventuate.

- Final endorsement of the governance structure, strategic plan and constitution.

The above have had serious impact on the development of the capacity of MECCN to be civil society leader in the work conservation of biodiversity and protection of the environment. These inhibit the registration thus recognition of MECCN.
