II. OPENING REMARKS

Provide any opening remarks that may assist in the review of this report.

The project carried out monitoring and investigation of illegal logging and forest conversion activities in the Jambi parts of the Bukit Tigapuluh ecosystem.

III. NARRATIVE QUESTIONS

1. What was the initial objective of this project?

Investigative report on illegal logging activities in the Jambi parts of Bukit Tigapuluh Ecosystem to support Eyes on the Forest (EoF).

2. Did the objectives of your project change during implementation? If so, please explain why and how.

No significant change so far. Only in setting work plan, where the field activity effectively began in the beginning of January 2007. Because, after signatory agreement with CEPF, that the former Executive Director of AlLInst (Ade Chandra) was resigned by the end of October 2007. And it took time to recruit and need time in orientation and in adaptation as well for the new director and also the staffs.

3. How was your project successful in achieving the expected objectives?

The project has carried out monitoring and investigation of illegal logging and forest conversion activities by companies. These activities were focused in the Jambi parts of Bukit Tigapuluh ecosystem, especially in Tebo and Tanjung Jabung Barat districts, Jambi Province.

From the result of monitoring and investigation, the project was successful collecting information and those related data, like: variety documents on licenses of logging/timber plantation concession and oil palm plantation concession, timber tracking from hewing/harvesting location to pulp and paper industries, as well as forest conversion or land clearing activities by companies. Each location have marked its coordinate point by

GPS (Global Positioning System) and also done taking photographs by digital camera. And other information/data related to that.

Beside that, AlLInst investigators team also did joint investigation with Eyes on the Forest (EoF) that represented by WALHI Riau in March 2007. This joint investigation was focused to get information about activity of timber plantation companies, PT Wira Karya Sakti/WKS and PT Rimba Hutani Mas/RHM (APP– Sinar Mas Group) in Jambi which owns PT Lontar Papyrus Pulp & Paper Industries (LPPPI) and targeting forests around the Bukit Tigapuluh National Park in Jambi, especially at Tanjung Jabung Barat district. But afterwards there was no coordination with EoF to follow up this activity. Even though, this joint investigation gave enough benefit for each investigator because it contributed them experience with investigation technique and different approach. Meanwhile sharing information/data Allinst with Eof was finally conducted through WARSI.

Meanwhile, to chase the activities output, the investigation activities was also collaborated with WALET (Wahana Alam Lestari), a local NGO in Jambi. This investigation activity was focused to dig up information/data about company activities, especially PT WKS (APP-Sinar Mas Group) at two villages where high potential conflict area and also adjacent with the Bukit Tigapuluh National Park, those are: Lubuk Madrasah Village in Tebo District and Lubuk Kambing Village in Tanjung Jabung Barat District.

4. Did your team experience any disappointments or failures during implementation? If so, please explain and comment on how the team addressed these disappointments and/or failures.

Since the limitation of human resources of AILInst and the limitation of access information to local government, so to get data at the district and provincial level was supported by WARSI and Bukit Tigapuluh Consortium which formerly had activities in Bukit Tigapuluh ecosystem. And to produce good map to field survey was also supported by WARSI as well.

5. Describe any positive or negative lessons learned from this project that would be useful to share with other organizations interested in implementing a similar project.

It was important to have network and collaboration with other NGOs, both for sharing information/data and experiences and strengthens advocacy campaign to combat illegal logging and or other forest crimes. Therefore, besides having collaboration with WARSI and Bukit Tigapuluh Consortium as mentioned above, to support the advocacy campaign, AILInst was also be the initiator and member of Jaringan Kerja Penanggulangan Kejahatan Kehutanan/JKPKH (NGOs Action Network for Combating Forest Crime) and Lembaga Bantuan Hukum Lingkungan/LBHL (Environment Law Service Institute).

6. Describe any follow-up activities related to this project.

Allinst be one of initiator of 6 other NGOs (AMPHAL, Cakrawala, Forja, Gita Buana, PSHK-ODA and YLBHL) in establishing NGOs Action Network for Combating Forest Crime (JKPKH). The portion of AlLInst in this network was investigation and study on

modus operand of forest crimes in Jambi Province including Bukit Tigapuluh ecosystem. Meanwhile, other institution in this networking is handling community facilitation as action prevention. This networking is very important for AILInst in doing joint advocacy campaign to follow up the investigation and study results.
